Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

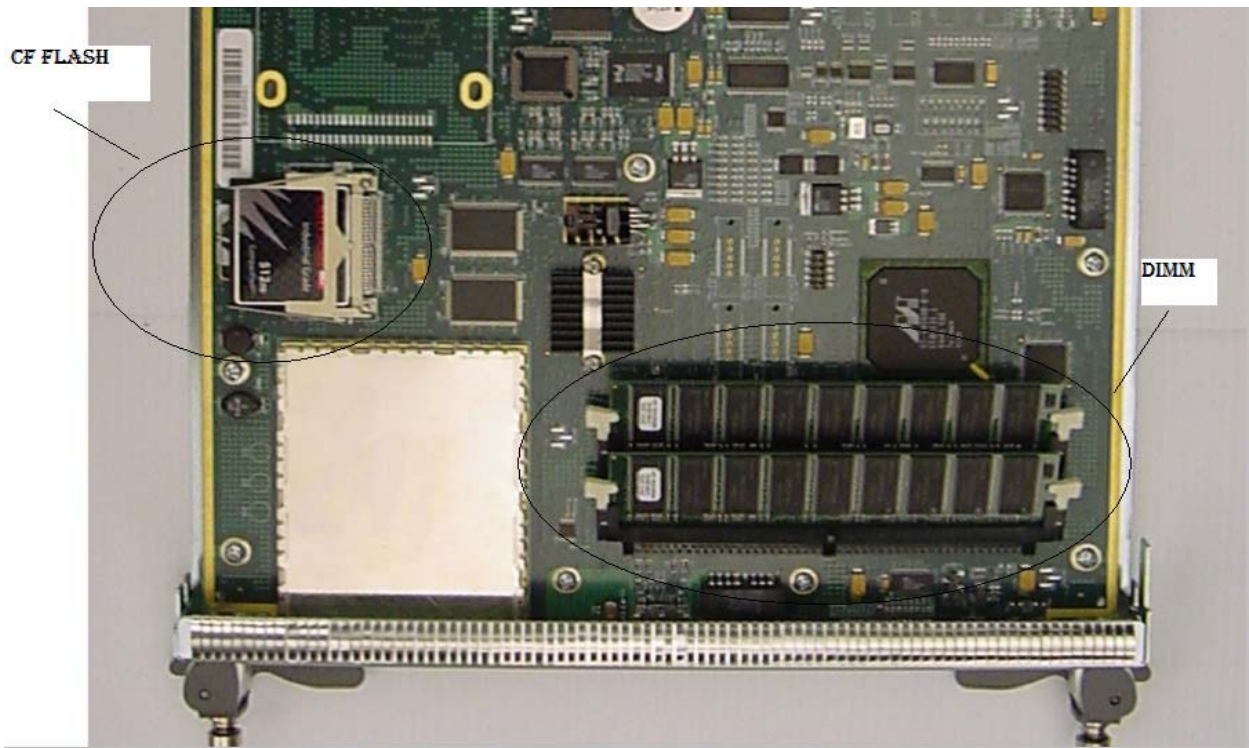
3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

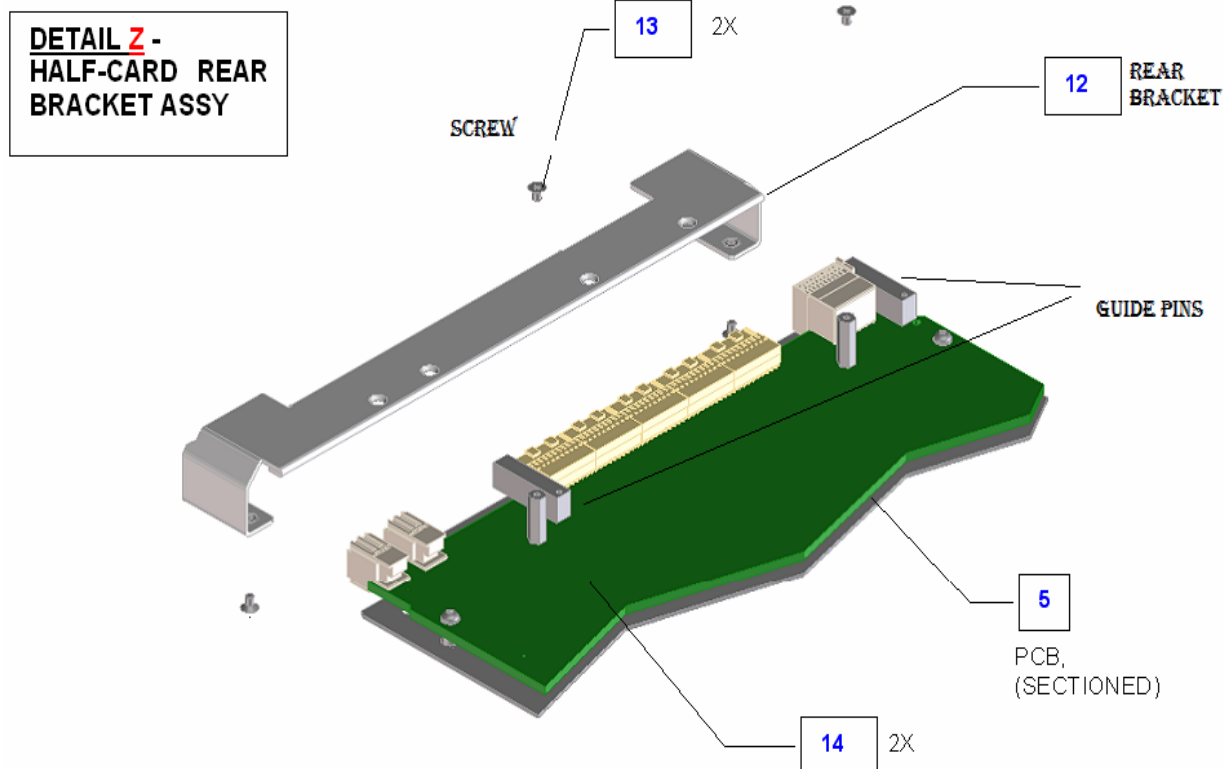
1. Remove the CF flash & the DIMM from the CF & DIMM holder. This is applicable for Product J8731A only. Refer to Picture 1 for more details.
2. Remove the SC cables connecting the transponder as well as the clip holding the cables onto the PCA. This is only applicable for Product J8733A. Refer to Picture 5 for more details
3. Remove the rear bracket by unscrewing 2 of screws on the top and 2 screws on the bottom of the bracket. Refer to Picture 2 for more details.
4. Separate the rear bracket from the PCA.
5. Remove the screws securing the bulkhead to PCA using a Philips Head screw driver.
6. Remove the EMI gasket from the top (1 per) and the side (2 per) of the bulkhead. Refer to Picture 3 for more details.
7. Remove the screws securing the clip to heat sink using a Philips screw driver. Refer Picture 4 for more details
8. Separate the clip & standoff the heat sink.
9. Remove the screws securing the guide pins to the PCA using a Philips screw driver. See Picture 2 for more details.
10. Separate the guide pins, heat sink, clip, standoff, EMI gasket, PCA and bulkhead

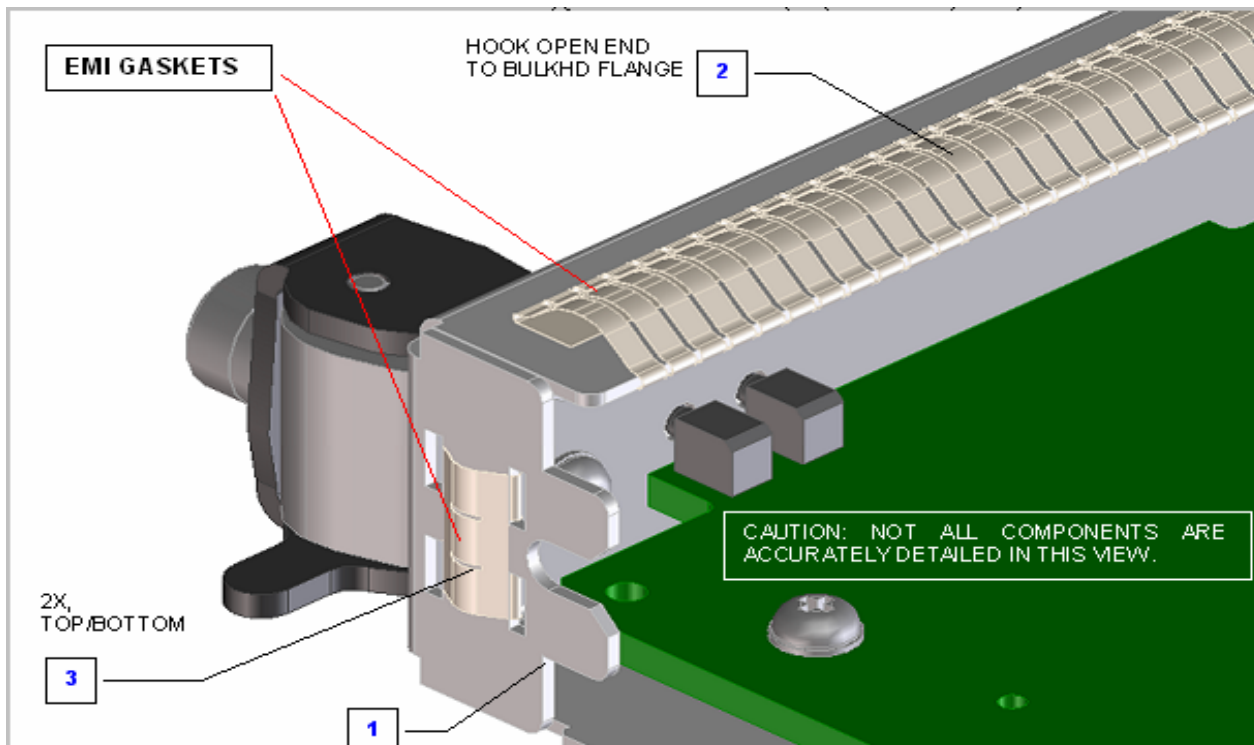

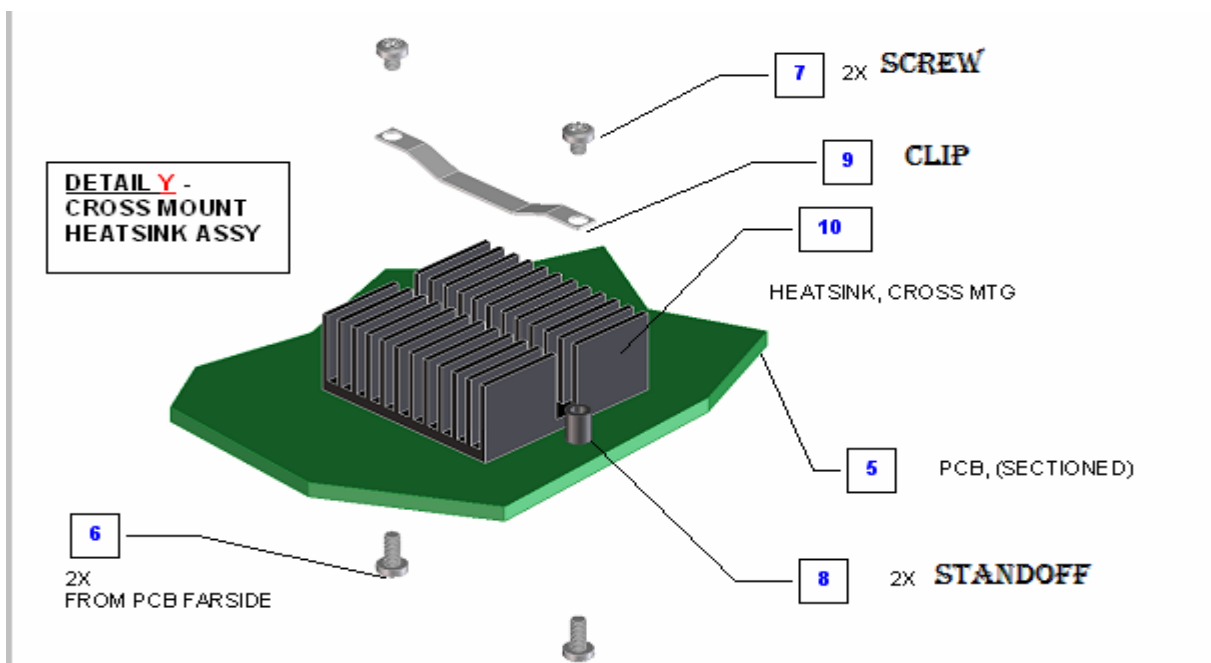
