Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Remove any blank slot cover and installed module by disengaging the two retaining screws on each slot cover/module and pull the cover/module out. Refer to relevant module product disassembly instructions to remove components/materials requiring selective treatment on modules.
2. Remove power supply unit(s)/blank cover at rear of chassis. Refer to power supply product disassembly instruction to remove components/materials requiring selective treatment in power suppliers
3. Remove remaining metal plate above the power supply slots by removing relevant screws
4. Disconnect the fan tray connector and remove all screws on the PCA. Remove the PCA by pulling on the circular pull tab at the top of the PCA.
5. Remove two bolts on RS232 connector on front bezel of chassis. Then remove the console PCA by sliding it to the rear of the chassis.
6. Remove fan tray assembly by removing two torx screws on left side cover at rear and slide the tray out the rear of the chassis.
7. Remove plastic side cover by sliding it toward front chassis to disengage catches
8. Remove plastic top cover by lifting left edge of cover and simultaneously sliding to left to disengage catches
