



# Product End-of-Life Disassembly Instructions

**Purpose:** The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

## 1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

## 3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Remove metal bulkhead by removing the screws securing the bulkhead onto the PCA and by pulling the bulkhead away from the PCA.
2. Remove the two screws and springs on both sides of the bulkhead
3. Remove the button style battery from the small PCA
4. Remove the small PCA by pulling it away from the main PCA
5. Remove any Flash on the small PCA by pulling it away from the PCA
6. Remove the Dimm from the big PCA by pressing the catch at both side of the DIMM
7. There's 2 heatsinks (one with screws and the other have no screws on it), unscrew the screws on the heatsink and remove it by pulling it away from the PCA. For the heatsink without screw on it, release catch on the heatsink by pressing the wire catch. Remove the heatsink by pulling it away from the PCA
