



# Product End-of-Life Disassembly Instructions

**Purpose:** The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

## 1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

## 3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on mounting angle 1, and then remove mounting angle 1.
2. Unscrew the screws on cover 2, and then remove cover 2.
3. Remove all of the inner cables.
4. Remove film 3 from panel set 5.
5. Remove film 4 from panel set 5.
6. Remove plastic panel 5 from base 6.
7. Unscrew the screws on power supply 7, and then remove power supply 7.
8. Unscrew the screws on power bracket 8, and then remove bracket 8.
9. Unscrew the screws on PCB 9, and then remove PCB 9.
10. Remove power cable 10 from the chassis.
11. Unscrew the screws on fan 11, and then remove fan 11 from base 6.
12. Unscrew all screws on mother PCB 12 , and then remove mother PCB 12 from the chassis.
13. Remove all of the labels from the chassis.




Figure 1 Treatments to the product




Figure 2 Treatments to the product
