Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew antenna 1, and then remove antenna 1.
2. Remove four plastic feet 2.
3. Unscrew the screws on cover 4, and then remove cover 4.
4. Remove the film 5 from cover 4.
5. Remove all of the inner cables.
6. Remove RF card 6.
7. Unscrew the screws on PCB 7, and then remove PCB 7.
8. Remove all of the shielding fingers from chassis 3.
9. Remove all of the insulation pad from chassis 3.
10. Remove all of the labels.

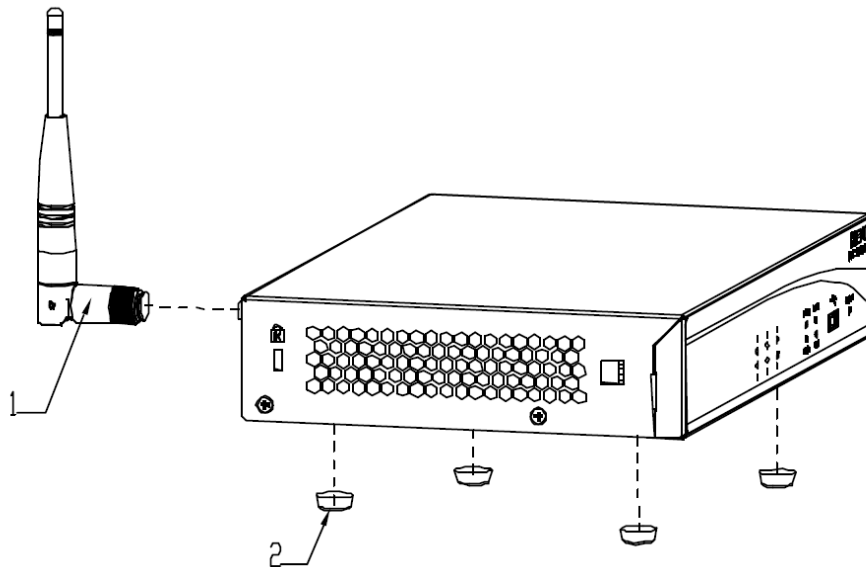


Figure 1 Remove antenna and plastic foot

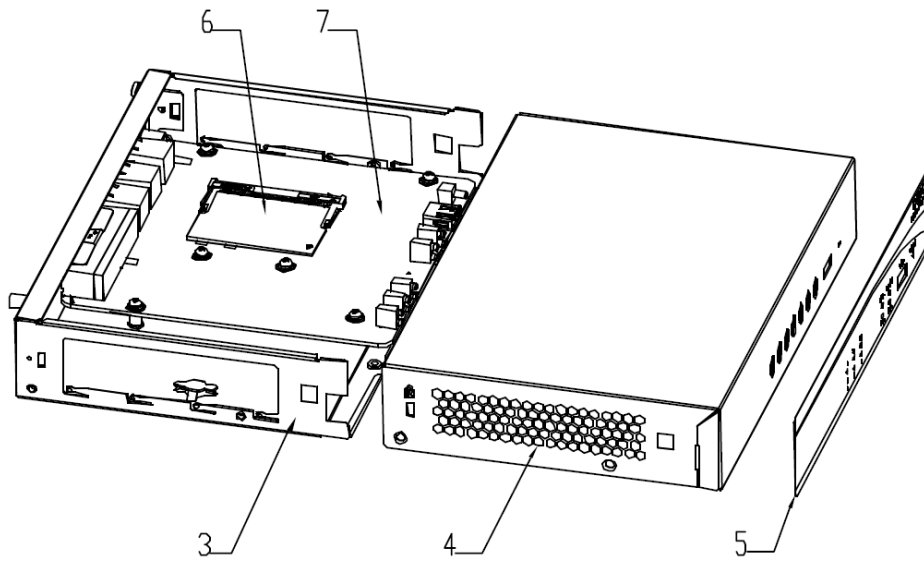


Figure 2 Treatments to the product
