It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Remove the antenna 1.
2. Unscrew the screws on card 2, and then remove card 2.
3. Unscrew the screws on top cover3, and remove top cover3.
4. Unscrew the screws on guide rail 9, and then remove guide rail 9.
5. Unscrew the screws on panel 11, and then remove panel 11.
6. Unscrew the screws on card12, and then remove card 12.
7. Remove card 13.
8. Remove all of the inner cables.
9. Unscrew the screws on PCB 14 and then remove PCB 14.
10. Remove guide rail 8.
11. Unscrew the screws on power supply PCB 6, and then remove power supply PCB 6.
12. Unscrew the screws on PCB 15, and then remove PCB 15.
13. Remove rocker switch 5 from the chassis.
14. Remove power connector 4 from the chassis.
15. Remove all of the shielding finger 10.
16. Remove all of the labels.




Figure 1 Rear of the product




Figure 2 Treatments to the product
