**Purpose:** The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

### 1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.



## 3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on sheet metal 1, and then remove sheet metal 1 from fan frame 6.
2. Unscrew the screws on fan 2, and then remove fan 2 from fan frame 6.
3. Unscrew the screws on pcb 3, and then remove pcb 3 from fan frame 6.
4. Unscrew the screws on Fan Plastic Module 4, and then remove Fan Plastic Module 4 from fan frame 6.
5. Remove shielding finger 5 from fan frame 6.
6. Remove Button 4-2 from Fan Plastic Panel 4-1.
7. Remove Spring 4-3 from Fan Plastic Panel 4-1.
8. Remove Cover Plate 4-4 from Fan Plastic Panel 4-1.
