Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

1.2 Enter the quantity of items contained within the product which require selective treatment in the right column, as applicable.

2.0 Tools Required

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on mounting angle 10, and then remove mounting angle 10.
2. Unscrew the screws on card 1, and then remove card 1.
3. Unscrew the screws on filler panel 2, and then remove filler panel 2.
4. Unscrew the screws on cover 3, and then remove cover 3 according to figure 4.
5. Remove all of the inner cables.
6. Unscrew the screws on power supply 4, and then remove power supply 4.
7. Unscrew the screws fan 5, and then remove fan 5. The others should be removed in the same way.
8. Unscrew the screws on PCB 6, and then remove PCB 6.
9. Unscrew the screws on PCB 7, and then remove PCB 7.
10. Remove plastic panel 8 from the chassis.
11. Remove all of the labels from the chassis.

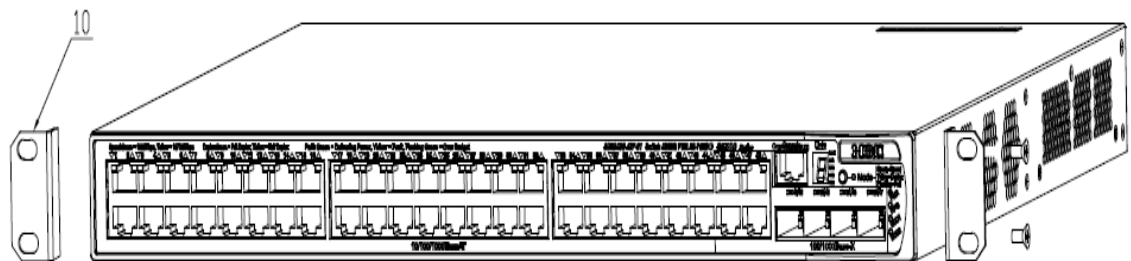


Figure 1 Remove mounting angle

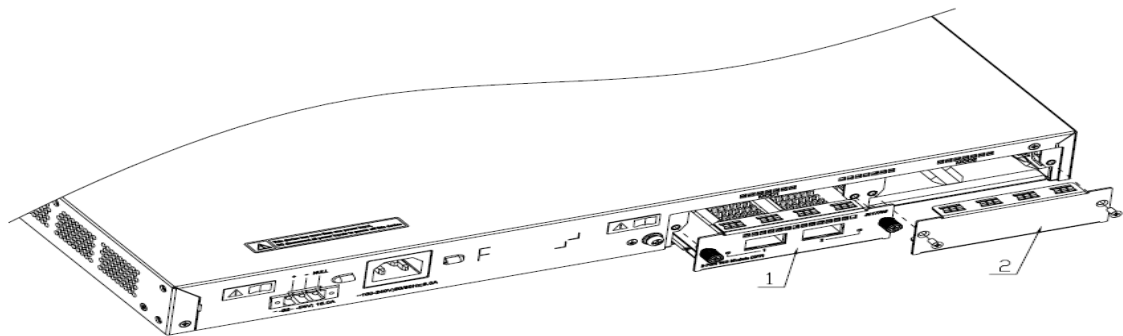


Figure 2 Rear of the product

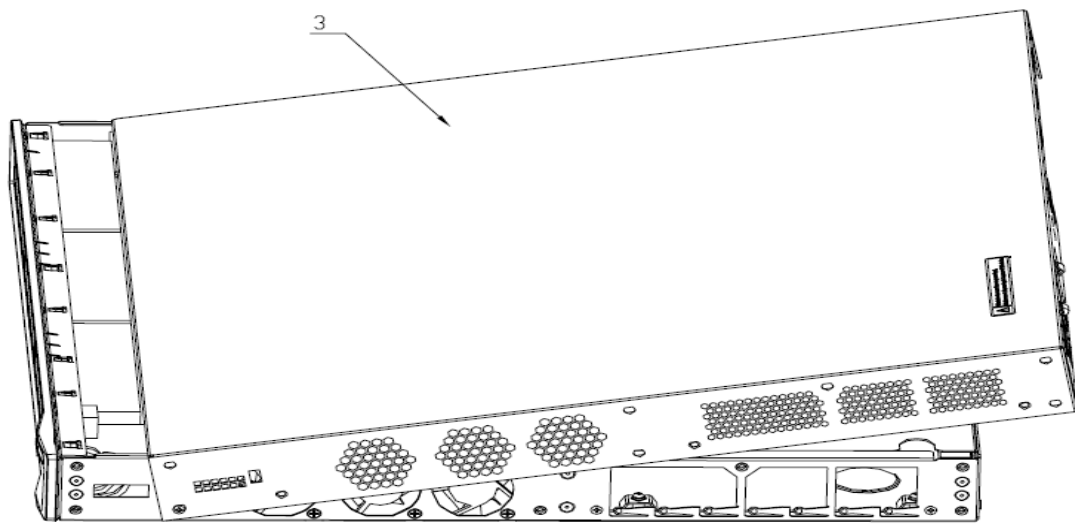


Figure 3 Remove cover

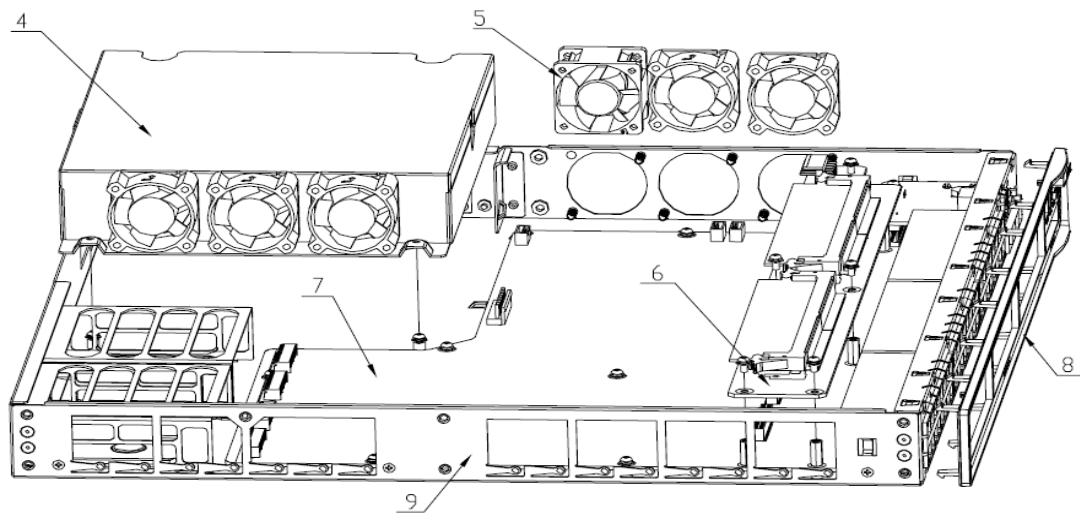


Figure 4 Treatments to the product (remove cover)
