Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

- 1. Unscrew the screws on part 1, and then remove part 1.
- 2. Unscrew the screws on part 2, and then remove part 2.
- 3. Unscrew the screws on part 3, and then remove part 3.
- 4. Unscrew the screws on PCB 4, and then remove PCB 4.
- 5. Remove part 5 from the part 6.
- 6. Remove part 4-2 from the PCB 4-1.

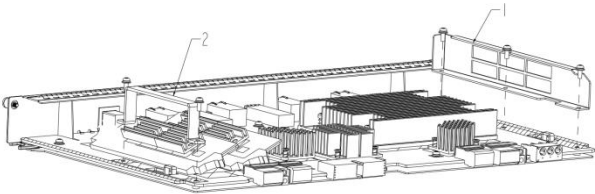


Figure 1 Treatments to the product

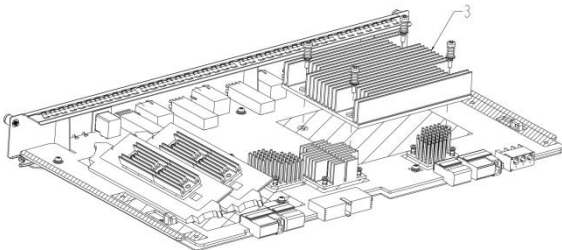


Figure 2 Treatments to the product

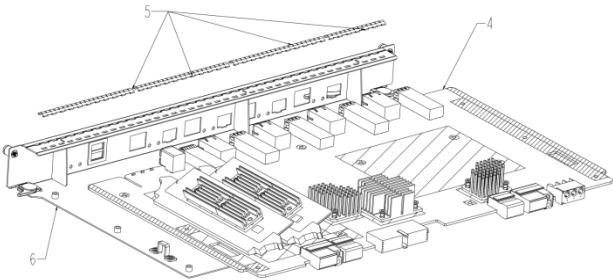


Figure 3 Treatments to the product

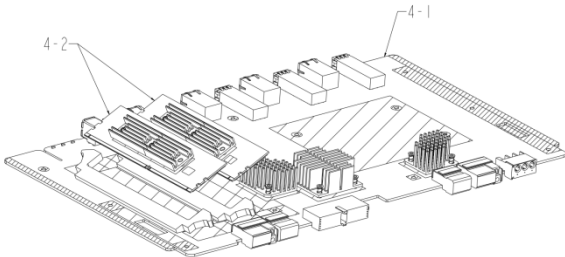


Figure 4 Treatments to the product
