Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEE)

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

1. Unscrew the screws on part 1, and then remove part 1.
2. Unscrew the screws on part 2, and then remove part 2.
3. Unscrew the screws on part 3, and then remove part 3 and part 5.
4. Unscrew the screws on part 6, and then remove part 6.
5. Unscrew the screws on part 7, part 8, part 9, and then remove part 7, part 8, part 9.
6. Unscrew the screws on part 10, and then remove part 10 from part 4.




Figure 1 Remove part 1




Figure 2 Remove part 2




Figure 3 Treatments to the product




Figure 4 Treatments to the product
