



# Product End-of-Life Disassembly Instructions

**Purpose:** The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

## 1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

1.2 Enter the quantity of items contained within the product which require selective treatment in the right column, as applicable.

## 3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on pcb 1, and then remove pcb 1 from pcb 2.
2. Remove screw stud 5 from pcb 2.
3. Unscrew the screws on pcb 2, and then remove pcb 2 from panel 9.
4. Remove sheet metal 4 from pcb 1.
5. Remove heat sinks 3 from pcb 2.
6. Remove shielding finger 7 from panel 9.
7. Remove film 6 and 8 from panel 9.

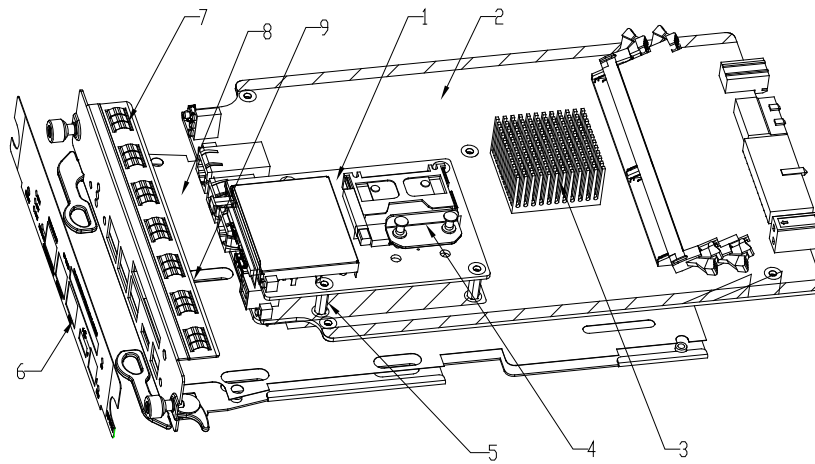


Figure 1 Explode View of the Front Panel

8. All the steps above see Figure 1. Remove the battery from pcb 1, and the detail steps as below:
  - a) Remove conformal coating (if any) and clean work area of any contamination, oxides, adhesives, residues or fluxes.
  - b) Install thermal drive desoldering tip handpiece
  - c) Start with tip temperature of approximately 315°C and change as necessary
  - d) Thermal shock tip with damp sponge

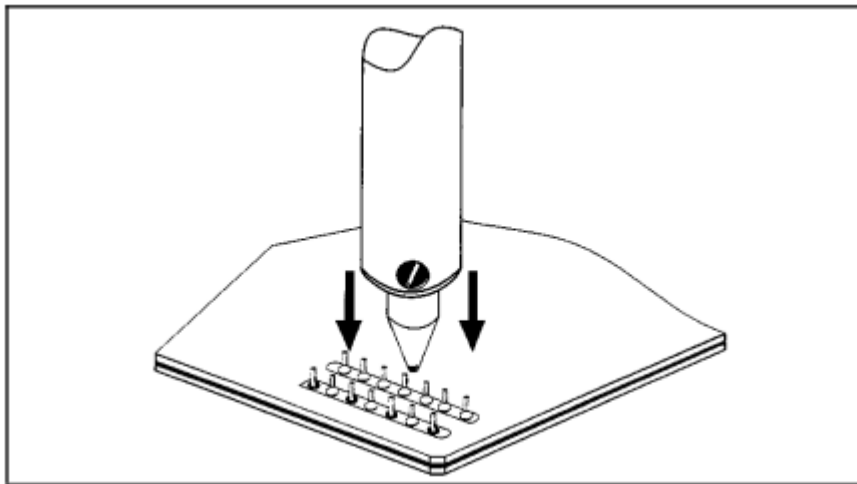


Figure 2 Position Tip

  - e) Tin tip with solder. (See Figure 2.)
  - f) Lower tip contacting solder connection.

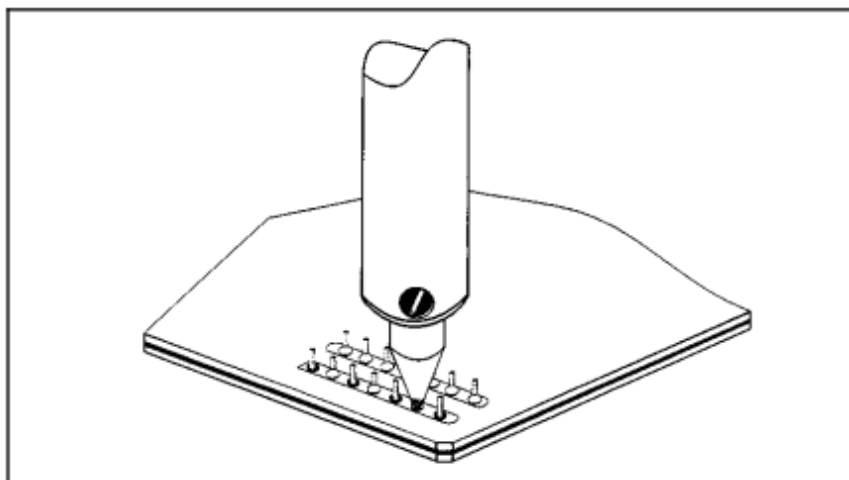


Figure 3 Melt Solder

  - g) Confirm complete solder melt of contacted lead. (See Figure 3.)

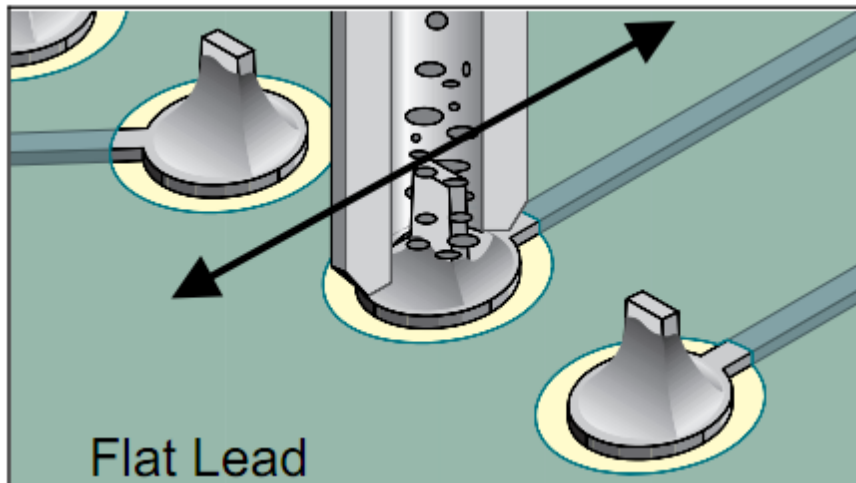


Figure 4 Move Lead & Apply Vacuum

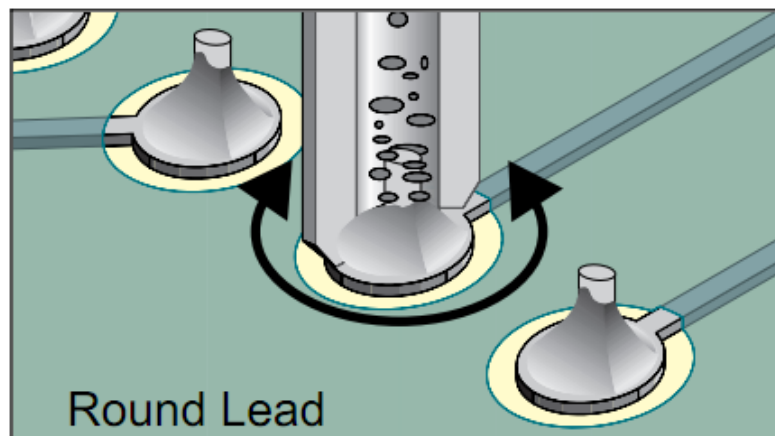


Figure 5 Move Lead & Apply Vacuum

  - h) For a flat lead, move lead back and forth; for a round lead, use a circular motion and apply vacuum while continuing lead movement. (See Figures 4&5.)

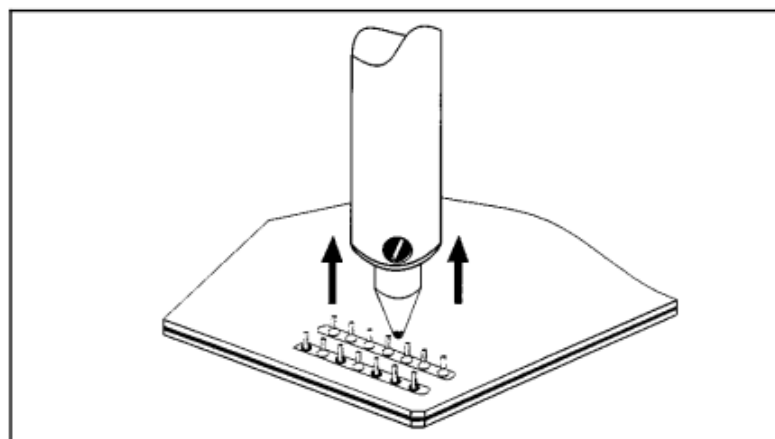


Figure 6 Lift Handpiece

  - i) Lift tip from lead, hold vacuum for an additional 3 seconds to clear all molten solder from heater chamber. (See Figure 6.)
  - j) Repeat for all solder connections.
  - k) Re-tin tip end with solder and return handpiece to its stand
  - l) Lift the component body free of the printed board
