Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Remove 4 phillips screws, 2 in each connector. The screws are stainless steel.
2. Remove both connector shells from cable. These 4 connector 1/2 shells are zinc alloy with copper and nickel plating. The 2 jack screws that were captured by the connector shells are nickel plated brass.
3. Cut plastic connector shells from cable at both ends. Remaining cable has PVC jacket.
