Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on reinforce board 2, and then remove reinforce board 2 from fan frame 5.
2. Unscrew the screws on fan 3, and then remove fan 3 from fan frame 5.
3. Unscrew the screws on fan 4, and then remove fan 4 from fan frame 5.
4. Unscrew the screws on pcb 1, and then remove pcb 1.
5. Remove shielding finger 6 from fan frame 5.
6. Remove film 7 from fan frame 5.
7. Remove film 8 from fan frame 5.

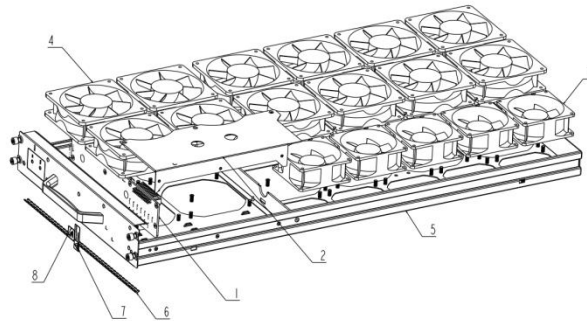


Figure 1 disassembly process
