Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on protection cover 1 and protection cover 2, and then remove protection cover 1 and protection cover 2 from fan frame 5.
2. Unscrew the screws on fan protect Net 3, fan protect Net 4, fan 6 and fan 7, and then remove protect Net 3, fan protect Net 4, fan 6 and fan 7 from fan frame 5.
3. Unscrew the screws on pcb 8, then remove the pcb 8 from fan frame 5.
4. Unscrew the screws on handle 9, and then remove handle 9 from fan frame 5.
5. Remove shielding finger 10 from fan frame 5.
6. Remove film 11 from fan frame 5.
7. Remove handle warning label 12 and fan caution label 13 from fan frame 5.

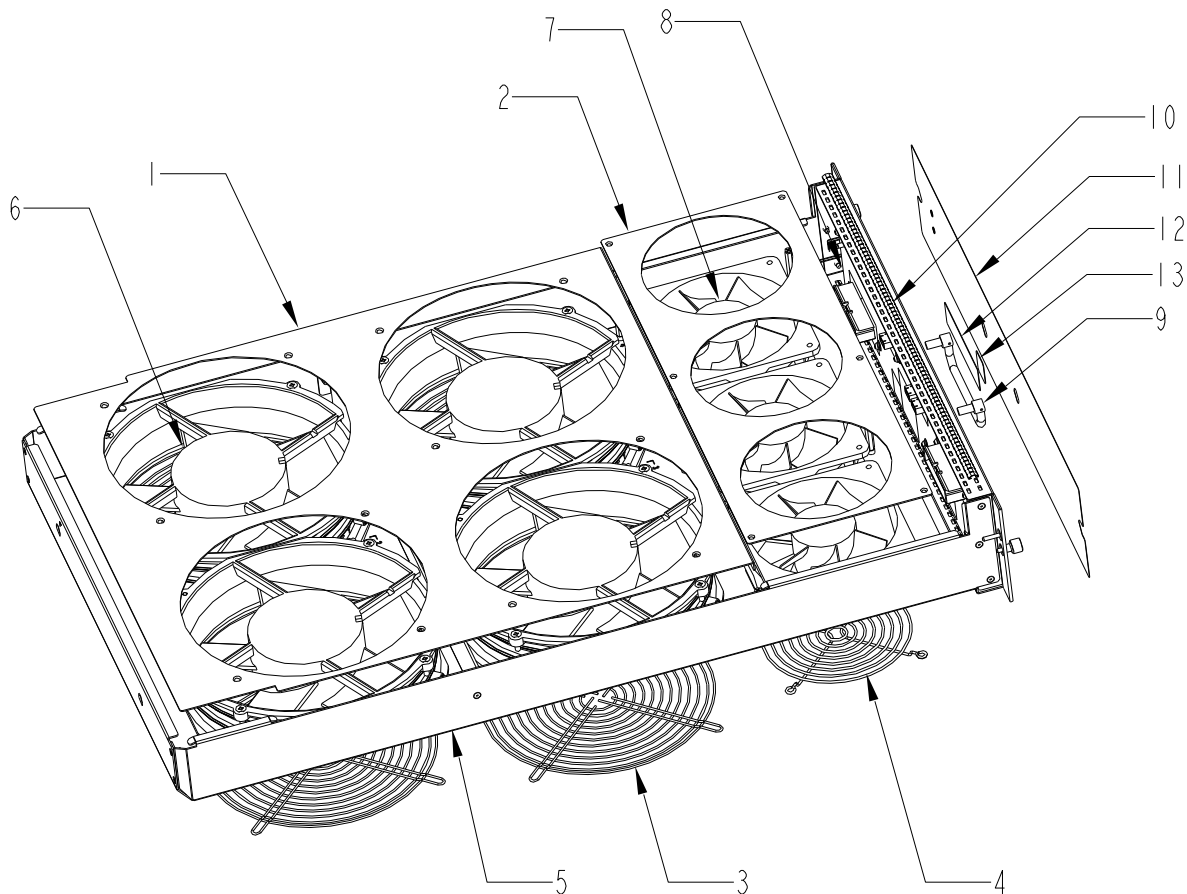
