Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Remove the film 1.
2. Unscrew the screws on part 2, and then remove part 2.
3. Remove shielding fingers 3 from part 2.
4. Unscrew the screws on heatsink 4, and then remove heatsink 4.
5. Unscrew the screws on part 5, and then remove part 5.
6. Unscrew the screws on PCB 6, and then remove PCB 6 from part 10.
7. Push part 7, and then remove part 8 and heatsink 7 from PCB 6.
8. Unscrew the screws on guide 9, and then remove guide 9 from PCB 6.

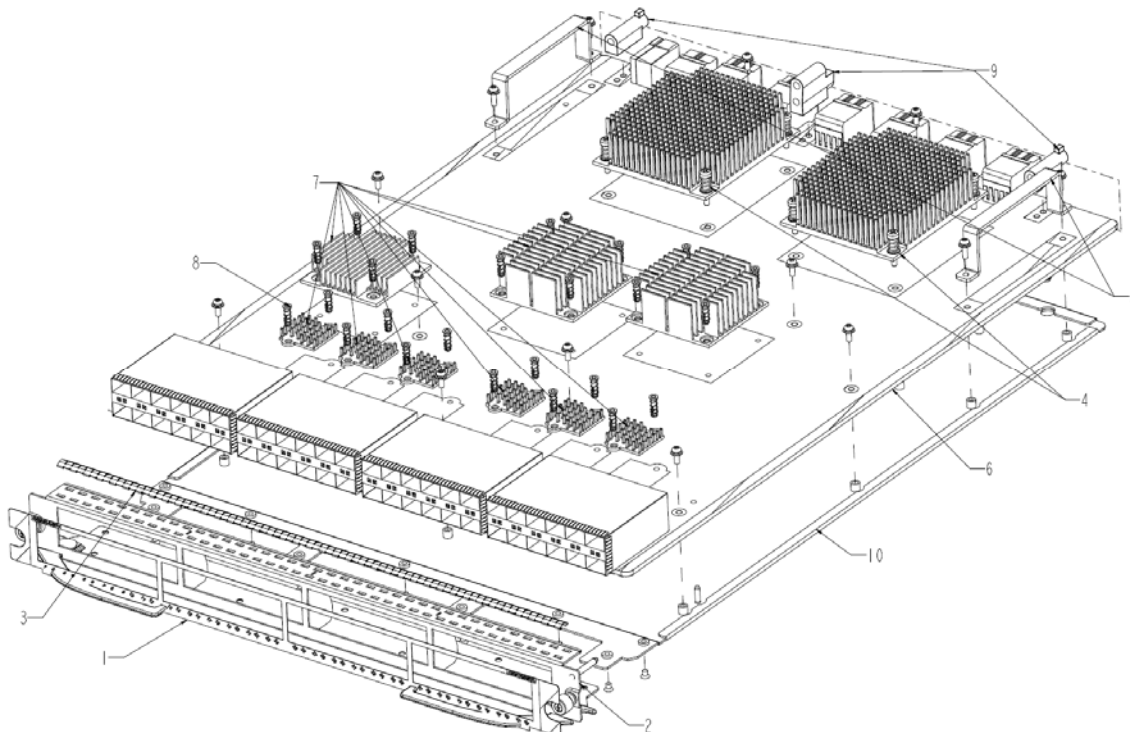


Figure 1 Treatments to the product
