Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Remove the film 1;
2. Unscrew the screws on part 2,and then remove part 2;
3. Remove part 3 from part 2;
4. Unscrew the screws on heatsink 4,and then remove heatsink 4;
5. Unscrew the screws on part 5,and then remove part 5;
6. Unscrew the screws on pcb 6,and then remove pcb 6 from part 14;
7. Push part 7,and then remove part 7 and heatsink 8 from pcb 6;
8. Push part 9,and then remove part 9 and heatsink 10 from pcb 6;
9. Push part 9,and then remove part 9 and heatsink 11 from pcb 6;
10. Unscrew the screws on part 12,and then remove part 12 from pcb 6;
11. Unscrew the screws on part 13,and then remove part 13 from pcb 6.

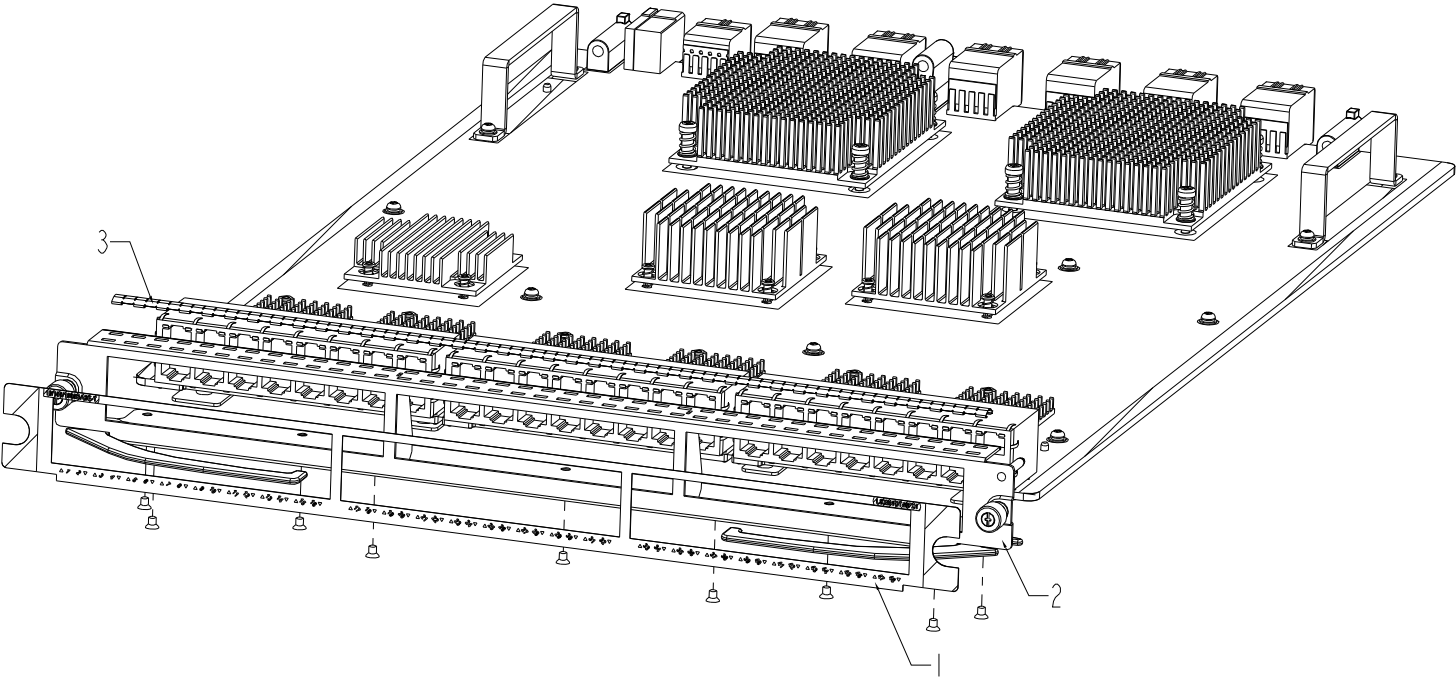


Figure 1 Treatments to the product

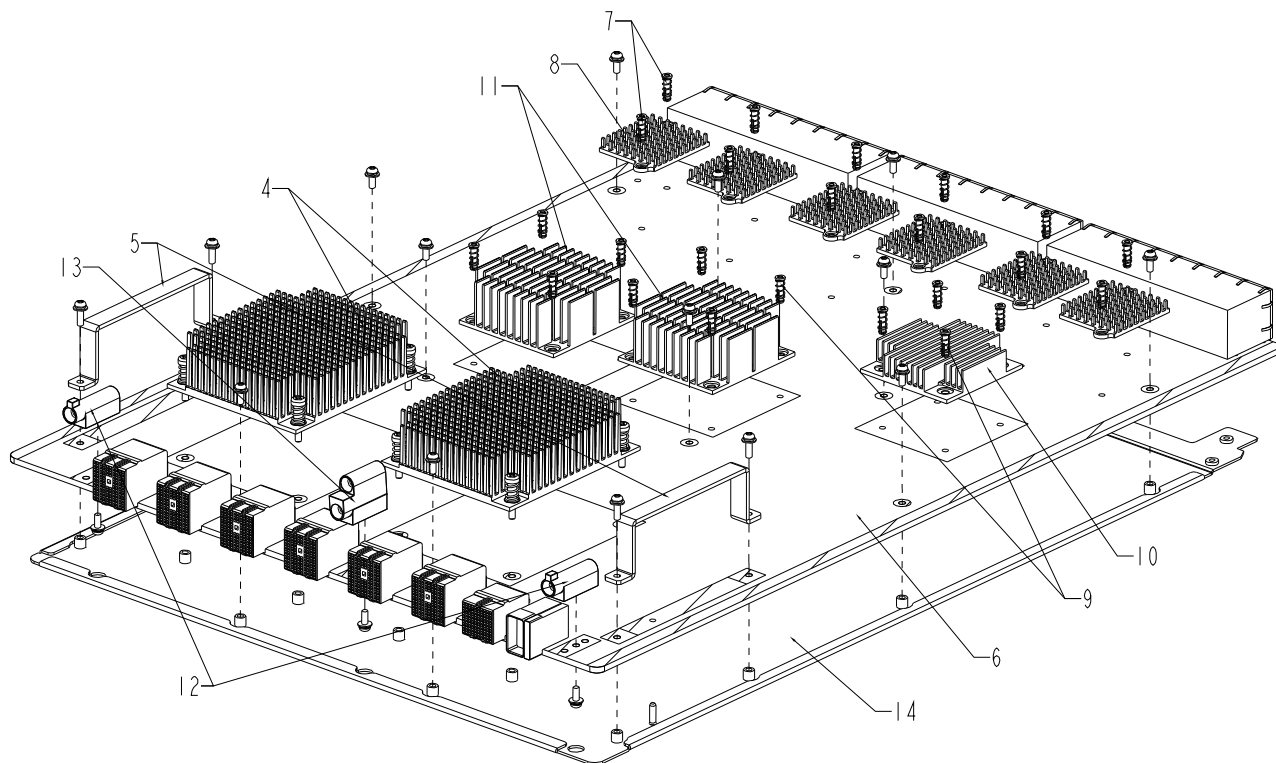


Figure 2 Treatments to the product
