



# Product End-of-Life Disassembly Instructions

**Purpose:** The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

## 3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on part 1 and 2, and then remove part 1 and 2;
2. Unscrew the screw nuts on PCB 3, and then remove PCB 3;
3. Unscrew the screws on PCB 4, and then remove PCB 4;
4. Remove the heatsink 5 from pcb 4;
5. Unscrew the screws on guiding set 6, and then remove guiding set 6;
6. Remove shielding finger 7 from panel 9;
7. Unscrew the film 8 from front plate 9;
8. Remove insulated sheet 9 and 10 from bottom plate 11;

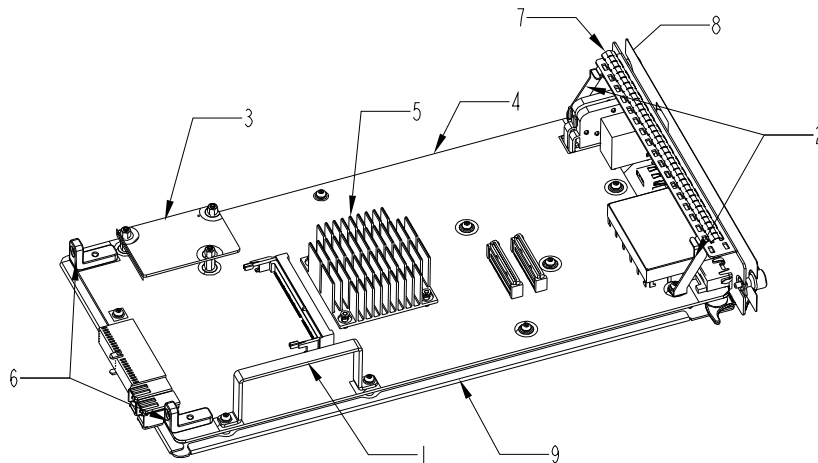


Figure1 Treatments to the product
