



# Product End-of-Life Disassembly Instructions

**Purpose:** The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

## 1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

## 3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Unscrew the screws on part 1, and then remove part 1;
2. Unscrew the screws on guiding set 2, and then remove guiding set 2;
3. Unscrew the screws on part 3, and then remove part 3 and part 4;
4. Remove the heatsink 5 and 6 from pcb 7;
5. Unscrew the screws on pcb 7, and then remove pcb 7 from panel 10;
6. Remove shielding finger 8 from panel 10;
7. Remove film 9 from panel 10.

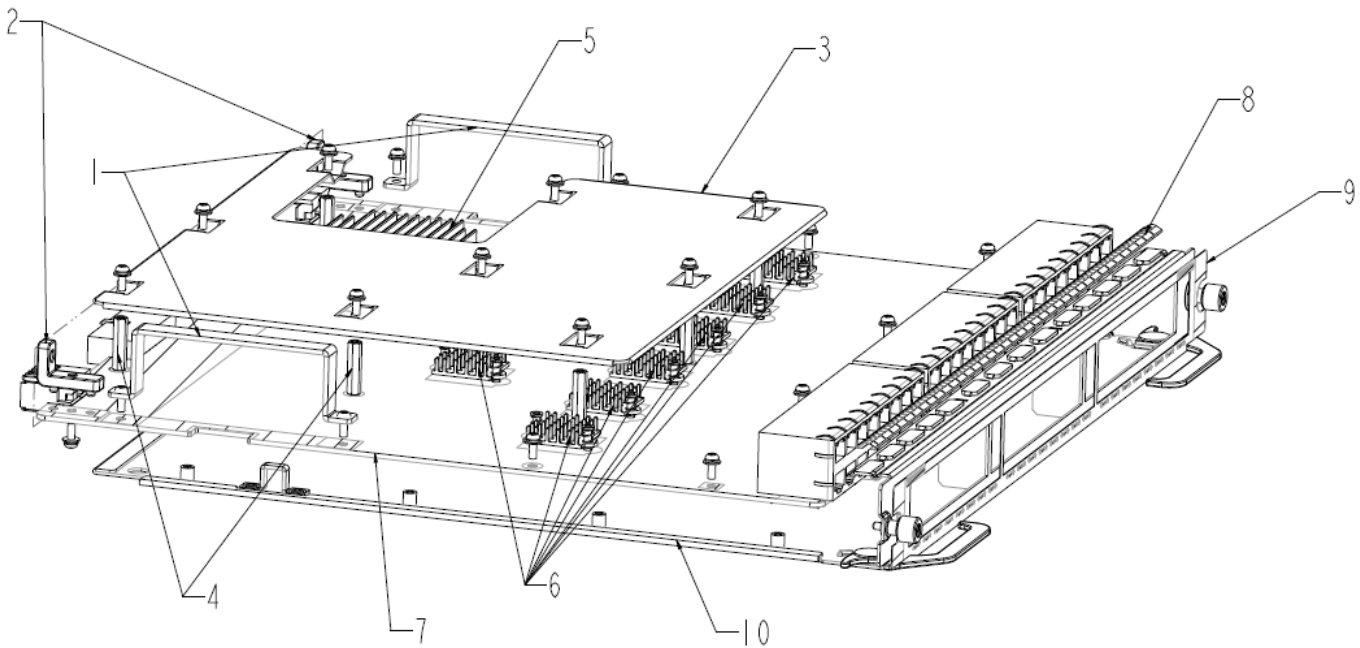


Figure1 Treatments to the product
