Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

2. Unscrew the screws remove fan 1 from bracket 2.
3. Unscrew the screws remove base 4 from front panel 3.
4. Remove all of the labels.

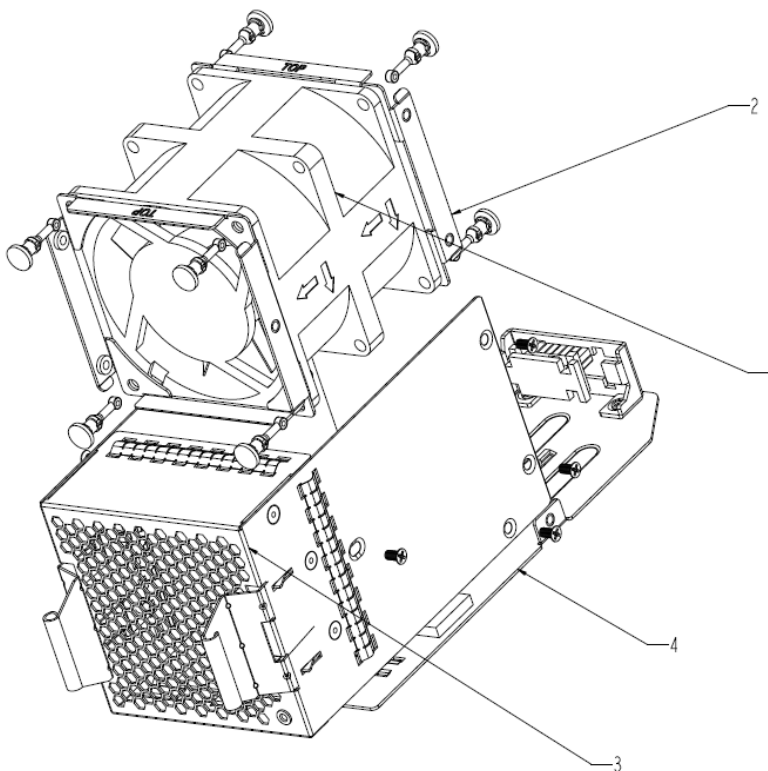


Figure 1 Treatments to fan-assembly
