Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

2.0 Tools Required

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. Using a T10 Torx driver (tamper-resistant), remove the 4 screws securing the 2 halves of the chassis.
2. Using a P2 Phillips screw driver, remove the 5 screws securing the antenna PCA.
3. Using wire cutters, remove the wires attached to the antenna PCA.
4. Using a P2 Phillips screw driver, remove the 4 screws securing the main PCA.
5. Using an adjustable wrench, remove the center fastener securing the middle of the main PCA.
6. Detach the 6 wires from the radio module PCAs mounted on the main PCA.
7. Using a P2 Phillips screw driver, remove the 2 screws securing a radio module PCA.
8. Remove the radio module PCA.
9. Using a P2 Phillips screw driver, remove the 2 screws securing the other radio module PCA.
10. Remove the other radio module PCA.
