Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

2. Unscrew the screws on part 2, and then remove part 2.
3. Remove part 4 from part 3.
4. Unscrew the screws on part 5, part 6, and then remove part 5, part 6.
5. Unscrew the screws on part 7 , and then remove part 7 from part 3.





Figure 1 Remove part1Figure 2 Remove part 2





Figure 3 Treatments to the productFigure 4 Treatments to the product




Figure 5 Treatments to the product
