Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HP products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

1. Unscrew the screws on mounting angle 0, and then remove mounting angle 0.
2. Unscrew the screws on SD splinter, and then remove SD splinter.
3. Remove the cover 2

5. Unscrew the screws on PCB 8, and then remove PCB 8.
6. Unscrew the screws on PCB 7, and then remove PCB 7.
7. Remove panel 6, insulate plate 5 and outlet 4
8. Remove all of labels




Figure1 Remove mounting angle




Figure2 Treatment to the product
