Purpose: The document is intended for use by end-of-life recyclers or treatment facilities. It provides the basic instructions for the disassembly of HPE products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

3.0 Product Disassembly Process

3.1 List the basic steps that should typically be followed to remove components and materials requiring selective treatment:

1. System Board Battery -- Locate the battery on the system board. Push the lock area of battery holder and remove the battery by hand.
2. System Megacell -- Remove the management module from system and locate megacell on the management board, then remove the megacell and dispose of properly.
3. Capacitors>2.5 cm -- Remove the PSU from the system. With screw driver, remove the screws securing the top cover, locate the capacitors and use a medium flat head screwdriver to remove them and dispose of properly.

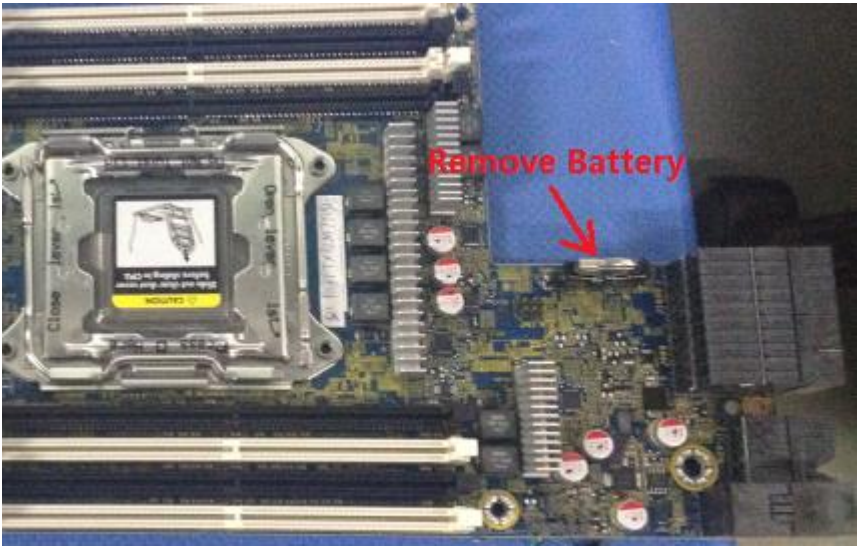

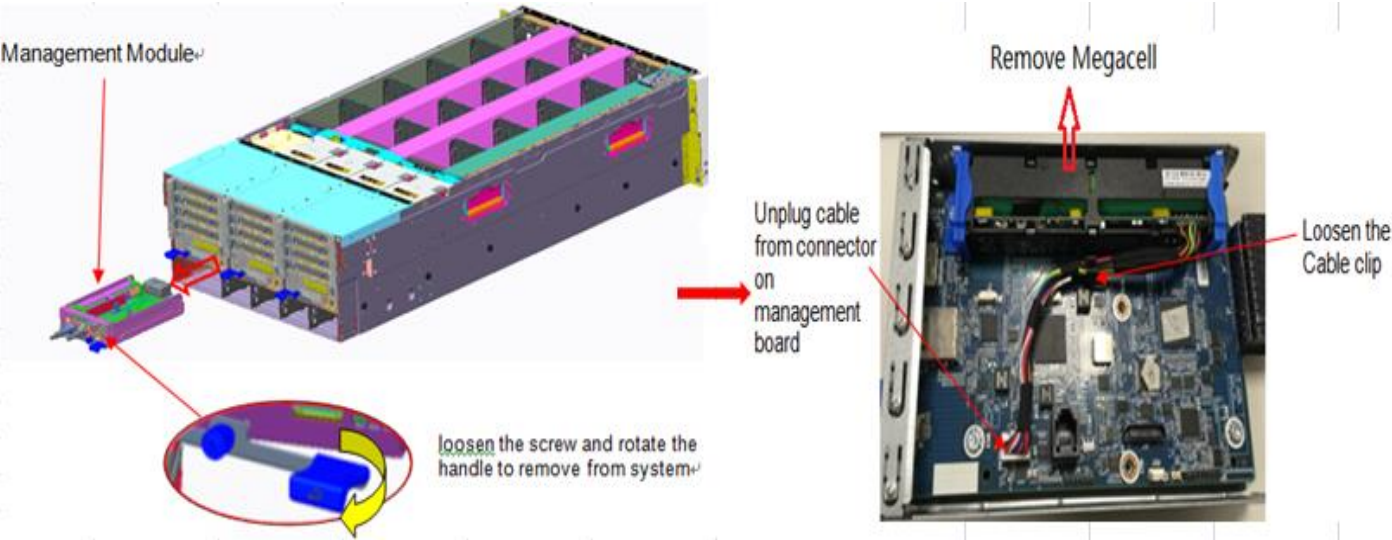
Attachment 2 -- MEGACELL Location

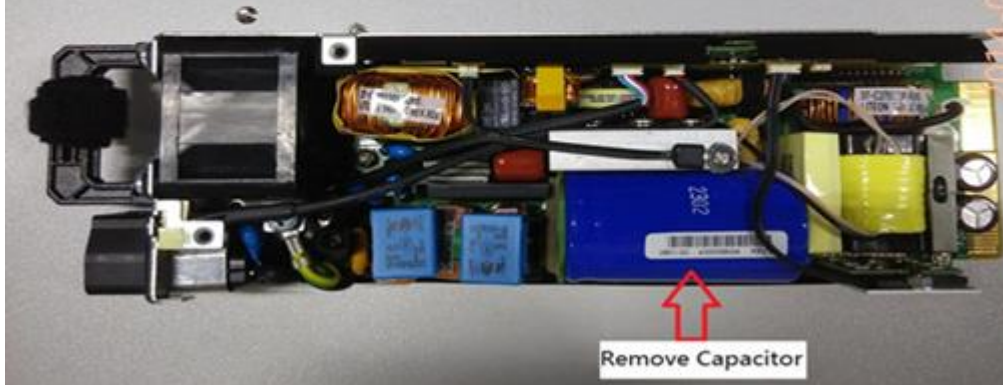

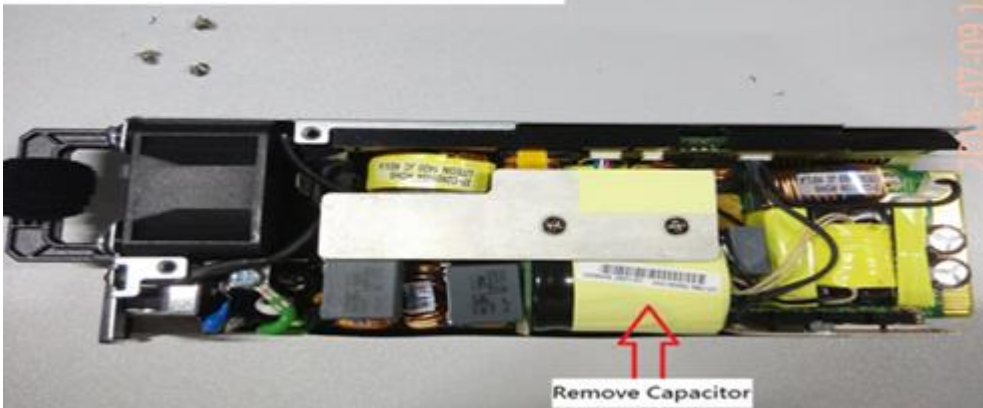

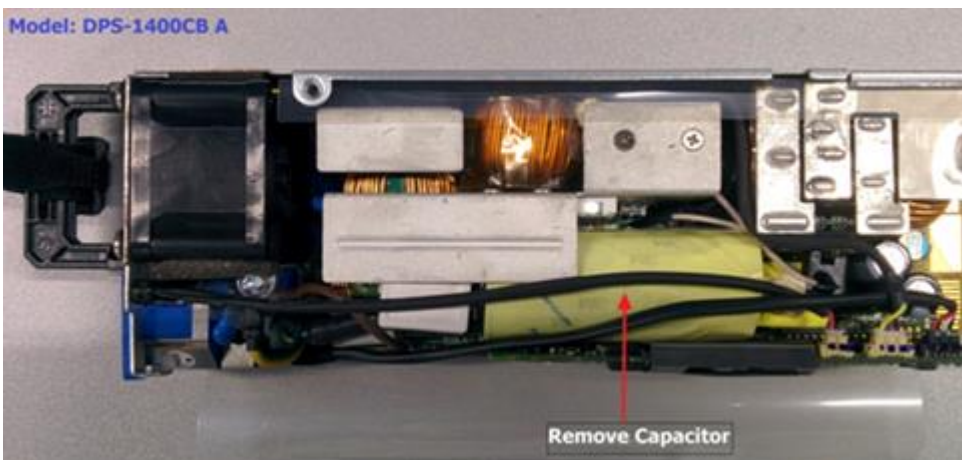

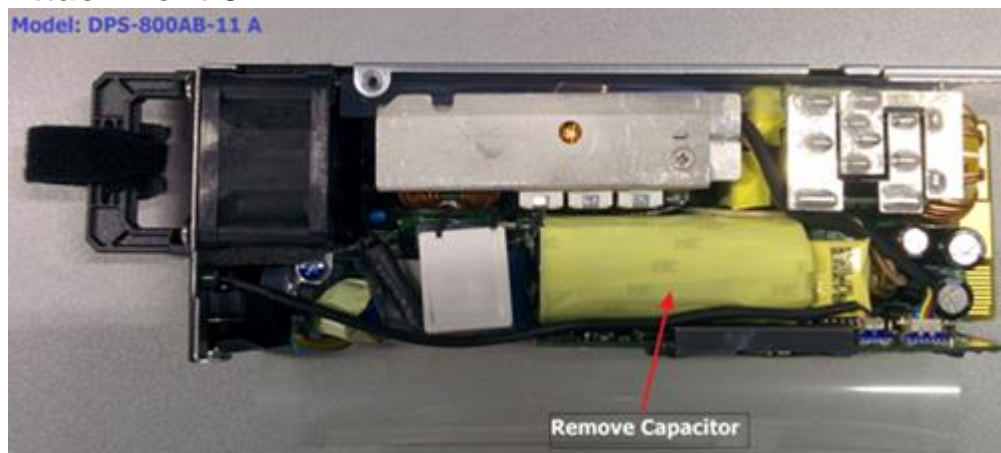
