

## **END USER LICENSE AGREEMENT**

***IMPORTANT: READ BEFORE ACTIVATING THE CONTENT FILTERING SERVICES***

### **3COM END USER LICENSE AGREEMENT**

**YOU SHOULD CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS BEFORE USING THESE SERVICES, THE USE OF WHICH IS LICENSED BY 3COM CORPORATION ("3COM") TO ITS CUSTOMERS FOR THEIR USE ONLY AS SET FORTH BELOW. USING ANY PART OF THE CONTENT FILTERING SERVICES INDICATES THAT YOU ACCEPT THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT, DO NOT ACTIVATE OR USE THE CONTENT FILTERING SERVICES, DO NOT CLICK ON THE "I AGREE" OR SIMILAR BUTTON. AND IF YOU HAVE RECEIVED ACCESS TO THE SERVICES ON PHYSICAL MEDIA, RETURN THE ENTIRE ITEM UNUSED TO THE SUPPLIER WHERE YOU OBTAINED IT.**

**LICENSE:** 3Com grants you a nonexclusive, nontransferable license to use the Content Filtering Services ("Services") and the underlying software program(s) and databases in executable form (the "Software"), subject to the terms and restrictions set forth in this Agreement. You are not permitted to lease, rent, distribute or sublicense (except as specified herein) the Services or Software or to use the Services or Software in a time-sharing arrangement or in any other unauthorized manner. Further, no license is granted to you in the human readable code of the Software (source code). Except as provided below, this Agreement does not grant you any rights to patents, copyrights, trade secrets, trademarks, or any other rights with respect to the Services or Software.

Subject to the restrictions set forth herein, the Services and Software are licensed to be used from any workstation or any network server owned by or leased to you, for your internal use, provided that the Services and Software are used only with the 3Com product in respect of which the Services are registered. You agree not to remove or deface any portion of any legend provided on any part of the Services or Software.

**NO REVERSE ENGINEERING; ASSIGNMENT:** Modification, reverse engineering, reverse compiling, or disassembly of the Services and/or Software is expressly prohibited. However, if you are a European Union ("EU") resident, information necessary to achieve interoperability of the Software with other programs within the meaning of the EU Directive on the Legal Protection of Computer Programs is available to you from 3Com upon written request.

You may transfer the use of the Services and the licenses granted herein to another party in the same country in which you obtained the Services if the other party agrees in writing to accept and be bound by the terms and conditions of this Agreement. If you transfer the Services, you must at the same time transfer the 3Com product in respect of which the Services are registered. Except as set forth above, you may not assign or transfer your rights under this Agreement.

**EXPORT RESTRICTIONS:** The Services, Software and all related technical data (and any copies thereof) (collectively "Technical Data"), may contain encryption. The Technical Data is subject to United States and European Union Export control laws and regulations and may be subject to export or import regulations in other countries, including controls on encryption products. You agree that you will not export, re-export or transfer the Technical Data (or any copies thereof) or any products utilizing the Technical Data in violation of any applicable laws or regulations of the United States or the country where you legally obtained it. You are responsible for obtaining any licenses to export, re-export, transfer or import the Technical Data.

In addition to the above, the Technical Data may not be used by, or exported or re-exported to (i) any U.S.- or EU- sanctioned or embargoed country, or to nationals or residents of such countries; or (ii) to any person, entity, organization or other party identified on the U.S. Department of

Commerce's Table of Denial Orders or the U.S. Department of Treasury's lists of "Specially Designated Nationals and Blocked Persons," as published and revised from time to time; (iii) to any party engaged in nuclear, chemical/biological weapons or missile proliferation activities, unless authorized by U.S. and local (as required) law or regulations.

**TRADE SECRETS; TITLE:** You acknowledge and agree that the structure, sequence and organization of the Software and the Services are the valuable trade secrets of 3Com and its suppliers. You agree to hold such trade secrets in confidence. You further acknowledge and agree that ownership of, and title to, the Software and all subsequent copies thereof regardless of the form or media and the Services are held by 3Com and its suppliers.

**UNITED STATES GOVERNMENT LEGENDS:** The Services and Software and any other technical data provided hereunder is commercial in nature and developed solely at private expense. The Software is delivered as "Commercial Computer Software" as defined in DFARS 252.227-7014 (June 1995) or as a commercial item as defined in FAR 2.101(a) and as such is provided with only such rights as are provided in this Agreement, which is 3Com's standard commercial license for the Software. Technical data is provided with limited rights only as provided in DFAR 252.227-7015 (Nov. 1995) or FAR 52.227-14 (June 1987), whichever is applicable.

**TERM AND TERMINATION:** The licenses granted hereunder are valid for one (1) year from the date of registration for the Services unless renewed for further one (1) year periods by the purchase of additional licenses, or unless terminated earlier as specified below. You may terminate the licenses and this Agreement at any time by deactivating the Services. The licenses will also terminate immediately if you fail to comply with any term or condition of this Agreement.

**LIMITED WARRANTIES AND LIMITATION OF LIABILITY:** 3Com warrants that the Services and Software will, if operated as directed in the user documentation, substantially achieve the functionality described in the user documentation for a period of ninety (90) days from the date of purchase from 3Com or its authorized reseller. No Software updates or upgrades are provided under this warranty. 3Com's sole obligation under this express warranty shall be, at 3Com's option and expense, to refund the purchase price for the Services or replace the Services with Services which meets the requirements of this warranty as described above. You assume responsibility for the selection of the appropriate programs and associated reference materials.

3Com makes no warranty or representation that the Services or Software will meet your requirements or work in combination with any hardware or software products provided by third parties, that the operation of the Services or Software will be uninterrupted or error free, or that all defects in the Services or Software will be corrected. For any third party products listed in the specifications as being compatible, 3Com will make reasonable efforts to provide compatibility, except where the non-compatibility is caused by a "bug" or defect in the third party's product or from use of the Services or Software not in accordance with 3Com's published specifications or user manual.

**WARRANTIES EXCLUSIVE, WARRANTY DISCLAIMER:** TO THE FULL EXTENT ALLOWED BY LAW, THE FOREGOING WARRANTIES AND REMEDIES ARE EXCLUSIVE AND ARE IN LIEU OF ALL OTHER WARRANTIES, TERMS OR CONDITIONS, EXPRESS OR IMPLIED, EITHER IN FACT OR BY OPERATION OF LAW, STATUTORY OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, WARRANTIES, TERMS OR CONDITIONS OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, SATISFACTORY QUALITY, CORRESPONDENCE WITH DESCRIPTION, NON-INFRINGEMENT AND QUIET ENJOYMENT, ALL OF WHICH ARE EXPRESSLY DISCLAIMED. 3COM NEITHER ASSUMES NOR AUTHORIZES ANY OTHER PERSON TO ASSUME FOR IT ANY OTHER LIABILITY IN CONNECTION WITH THE SALE, INSTALLATION, MAINTENANCE OR USE OF THE SERVICES OR SOFTWARE. IN PARTICULAR 3COM DOES NOT WARRANT, GUARANTEE OR MAKE ANY

**ENTIRE AGREEMENT:** This Agreement sets forth the entire understanding and agreement between you and 3Com and supersedes all prior agreements, whether written or oral, with respect to the Services and Software, and may be amended only in a writing signed by both parties.
